True North Fund Graduation Coaches

The Graduation Coach program was started at two high schools-Lincolnton and West Lincoln-in 2011 through funding received by CIS National from the Edna McConnell Clark Foundation's True North Fund. These positions work with students in the high schools to help them stay in school, on-track, and prepared for life beyond high school.

CIS After-School

The CIS After-school program currently operates in two Lincoln County middle schools during the school year. The program is funded through an ARRA Grant awarded through the Department of Juvenile Justice and Delinquency Prevention (DJJDP). The initiative was started in an attempt to reduce the instances of juvenile crime-both as perpetrator and as victims-during the hours of 3-6pm-a time when teenagers are most likely to be unsupervised. The program focuses on providing a safe, healthy, and fun alternative for students to utilize after-school. Participants receive a snack, help with their homework, and get to participate in group activities, community service projects, and field trips

The purpose of the program is to work with students at risk of dropping out of school and/or gang-involvement in Cleveland and Lincoln Counties. The Community Outreach Coordinator case-manages clients connecting them with needed community resources to help them stay in school and successfully plan for the future.

CIS Gives Back

The CIS Gives Back program was started in 2009 through funding from a Juvenile Crime Prevention Council grant.
